I waive, release and in advance, forgo my right to pursue any such claims causes of action or right to pursue civil damages against the Utah Reined Cow Horse Association its agents, volunteers, members, employees and/or cattle contractors whether for personal injury or for property damage including those alleged to have arisen out of negligent and/or grossly negligent act or omission. Further, I agree indemnify and to hold harmless the Utah Reined Cow Horse Association its agents, volunteers, members, contractors from any cost arising out of injury to myself (or my minor child) or to my property.

GENERALS RULES

1. A copy of your horse registration papers must be in our file before you show.
2. **Both owners & rider must be current NRCHA Members.** Please let the show secretary know if your membership is pending and provide one of the following: a temporary NRCHA CARD, a copy of your membership application or verification from the NRCHA.
3. All classes are NRCHA and Intermountain Circuit approved.
4. **NRCHA Rules will apply (Please sign waiver).** Show will pay back according to NRCHA Scale. URCHA has the right to cancel any class with 2 entries or less. Contestants will be notified prior to show.
5. **Checks will be written out to riders** and all winnings monies will be paid out at the show
6. **Bad checks will not be tolerated** and will be charged \$25. You must pay before you show. If you send in an entry – you are entered. Contact the secretary before the draw if you will not be there.
7. **Entries after the draw** will be first/last in the draw according to NRCHA Rules. Horses will run in the order drawn. A two minute gate call will be enforced. Contestants are responsible for double checking the draw and making sure they are entered in the appropriate classes. After the class has begun, class entries are official according to the draw.
8. **Intermediate Open – Snaffle Bit & Derby** – All horses entered in the Intermediate Division must enter the open division. For those entered in ONLY the open, all of their jackpot portion of the entry fee will stay in the open division. For those horses entered in both the open and intermediate, their jackpot portion of the entry fee will be split 2/3 to the Open and 1/3 to the intermediate.
